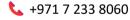

1 Overview of Grant Opportunities

The Sheikh Saud bin Saqr Al Qasimi Foundation for Policy Research offers a range of competitive grants to promote research, support arts and culture, and foster community-based collaborations in Ras Al Khaimah and across the United Arab Emirates.

Each program has distinct objectives, eligibility criteria, and application requirements, but all share a unified commitment to advancing knowledge, creativity, and social impact that contribute to evidence-based policy.

Applicants are encouraged to review each grant stream carefully and select the one that best aligns with their background, expertise, and intended outcomes.

3.1 Community Impact Grants

All applicants are expected to clearly demonstrate how their proposed research, artistic project, or community initiative will benefit Ras Al Khaimah and relate to the Foundation's priority areas: Education, Arts & Culture, Philanthropy, Community Development, and Public Health.

The Foundation recognizes that the application process may be time-consuming and welcomes general feedback requests regarding eligibility, relevance, or proposal strength.

1 | Research Grants

The *Research Grants Program* provides opportunities for scholars and practitioners to undertake applied, interdisciplinary projects that address pressing policy questions in Ras Al Khaimah and the wider United Arab Emirates.

1.1 TransformRAK Seed and Acceleration Grants

Overview

The Al Qasimi Foundation's TransformRAK: Research for *Tangible Impact Grants* is a program designed to bridge academic inquiry and real-world impact, policy-relevant solutions for Ras Al Khaimah and, by extension, the wider United Arab Emirates.

The program operates in two phases that encourage experimentation, refinement, and scaling of successful solutions.

Grant Type	Funding	Duration	Purpose
Seed Grant	Up to AED 75,000 per year	Maximum 24 months	To test new concepts, refine methodologies, and generate preliminary evidence for larger interventions.
Acceleration Grant	Up to AED 125,000 per year	Maximum 36 months	To expand proven initiatives, reach broader audiences or policy domains, and long-term impact.

Eligibility Requirements

- The Principal Investigator (PI) must be affiliated with one of the world's top 200 universities, as recognized by leading global ranking systems.
- The proposed project must be conducted within the United Arab Emirates, with preference for research activities based in Ras Al Khaimah.
- All applicants must satisfy the ethical approval and English language proficiency requirements outlined below.

English Language Proficiency Requirements

Applicants who learned English as a secondary language must provide evidence of proficiency through:

- Relevant academic writing samples, or
- Certified TOEFL iBT (minimum 102) or IELTS (minimum 7.5) results.

Applicants without recent scores may still apply; however, funding will be conditional upon later submission.

Exceptions may be granted for applicants with extensive academic or professional experience in English-language environments.

Research Ethics and Vulnerable Populations

Applicants whose projects involve human participants or vulnerable populations must secure Institutional Review Board (IRB) approval or complete CITI Program Human Subjects Research training prior to award activation. Equivalent training completed within the past two years may be accepted. Funding offers are conditional upon submission of ethics documentation. Recipients must adhere to international ethical standards and promptly notify the Foundation if their research uncovers issues related to child welfare or safety, in accordance with UAE law.

Application Process

Applications for the TransformRAK Seed and Acceleration Grants are accepted annually, with a submission deadline of 1 March (23:59 GST) unless otherwise advertised.

A complete application must include:

- An online application form submitted through the AQF Grants Portal.
- A cover letter and curriculum vitae for all principal researchers.
- Applicants must complete the official TransformRAK Proposal Template following all
 formatting requirements. This document should not exceed eight (8) pages and must adhere
 to the specified font and margin guidelines. The final proposal should be uploaded using the
 prescribed file naming format to ensure proper tracking.
- A short video introducing the project and explaining why it merits support.
- An implementation timeline and clearly defined deliverables.
- A detailed budget prepared using the Foundation's Appendix D2 Budget Template.
- Applicants are required to upload their CV, recommendation letter, letters of support, and IRB or CITI documentation when applicable.
- Additional materials may be included to strengthen the application but are optional
- Applicants must verify that all information and documents are accurate and represent their original work.

The full application must then be submitted through the AQF Grants Portal before the deadline.

Grant Inclusions:

Funding covers direct project-related costs associated with approved activities, up to AED 75,000 per year for Seed Grants and AED 125,000 per year for Acceleration Grants.

Permissible expenditures include, but are not limited to:

equipment and software purchases; travel to and within the UAE; accommodation; translation and transcription services; event hosting and workshop facilitation; printing and publication of research outputs; and other expenses directly tied to project delivery

Deliverables & Expectations:

Successful TransformRAK recipients are expected to contribute at least two knowledge-mobilization deliverables (e.g. policy brief, working paper, blog article, podcast) and to present their findings at a Research Majlis.

1.2 Doctoral Research Grants

The Doctoral Research Grant program supports promising PhD students whose dissertations involve substantial fieldwork in Ras Al Khaimah up to AED 60,000. These awards encourage early-career scholars to engage directly with the Emirate's communities, institutions, and policy environment, thereby building an evidence base that informs local development initiatives.

Grant Eligibility:

Applicants must be current PhD students of any nationality enrolled at an accredited university and in good academic standing.

Eligibility criteria include:

- For American programs: completion of all coursework and successful passage of preliminary examinations.
- For British or European programs: completion of at least one year of study, an extensive literature review, and a well-developed research methodology.
- The proposed research must include Ras Al Khaimah or the UAE as at least one part of the research.

English Language Proficiency Requirements:

Doctoral applicants who learned English as a secondary language must provide writing samples or certified TOEFL iBT (minimum 102) or IELTS (minimum 7.5) scores.

Applicants lacking recent test results may still apply; however, awards will remain conditional until submission of updated documentation.

Applicants with substantial academic or professional experience in English-language contexts may be considered for exemption.

Research Ethics and Vulnerable Populations:

All applicants conducting research involving human subjects must secure IRB approval or CITI Program certification before the award can be activated.

Equivalent documentation completed within two years of application will be accepted.

Recipients are expected to comply with international standards of ethical research and must inform the Foundation immediately if any concerns arise during fieldwork, particularly regarding child protection or participant safety.

Application Process:

Applications for Doctoral Research Grants follow the same annual cycle as TransformRAK, with a submission deadline of **1 March (23:59 GST)** unless otherwise announced.

A complete application must include:

a cover letter, curriculum vitae, official academic transcripts, a detailed research proposal, two

letters of recommendation, evidence of English proficiency (as applicable), and confirmation of ethical approval or IRB certification.

Grant Inclusions:

Awards provide comprehensive logistical and financial support for doctoral fieldwork. International applicants receive round-trip economy airfare (up to AED 8,000), up to 12 months of accommodation, a pro-rated monthly living stipend of AED 2,000 (maximum AED 24,000), car rental (AED 2,000 per month, maximum AED 24,000), visa costs (up to AED 2,500), and access to the Foundation's office and research facilities.

UAE-based applicants receive comparable benefits tailored to their needs, with up to AED 35,000 allocated for direct research expenses such as data collection, materials, or local travel.

Deliverables & Expectations:

Doctoral awardees must submit a final dissertation chapter draft or field report, share at least one knowledge output (policy brief, blog, or presentation), and engage with the Foundation's academic community through seminars or mentorship sessions.

2 | Arts Grants

The Arts Grants support creative expression and cultural exchange by enabling filmmakers and artists to produce original work that celebrates Ras Al Khaimah's identity, heritage, and contemporary life. These awards recognize the arts as essential to social cohesion, dialogue, and the preservation of cultural heritage.

2.1 Film Grants

The Film Grant provides financial and institutional support to directors and media professionals planning to produce short Arabic- and English-language films up to 20 minutes in length. Documentaries and projects that portray community narratives or social issues relevant to the UAE and Gulf region are particularly encouraged.

Grant Eligibility:

Young directors and media professionals of any nationality interested in making short bilingual films in Arabic and English (20 minutes or less) about topics relevant to the UAE and Gulf region, with documentaries especially encouraged. Directors should have a background in filmmaking or media studies and may be current university students (with at least two years of their academic program completed) or recent BA or MA graduates (within the last five years). They must also have screened at least one film at a festival in the UAE, Gulf region, or internationally. Priority is given to Emirati applicants.

Application Process:

Opens in early April 2025, with a closing deadline of 1 June 2025, unless specified otherwise. A complete application must include the online form, a cover letter, the director's CV, along with the

names and roles of other involved individuals, a detailed storyboard, an itemized budget, a timeline with key milestones, a list of filming locations with necessary permissions, a letter of recommendation, and two recent film samples. Finalists might be asked to participate in an inperson or Zoom interview.

Grant Inclusions:

A maximum of 35,000 AED is allocated to production-related activities in the detailed budget. Acceptable expenses include location and equipment rentals (such as studio time, lighting, sound equipment), make-up, costumes, props, purchasing or commissioning music soundtracks, editing or animation software, and Arabic/English translation and subtitles.

Deliverables & Expectations:

Film Grant recipients are required to submit a finished short film (up to 20 minutes), along with a project completion report and a recorded podcast. The Foundation reserves non-commercial rights to exhibit the film at Foundation events or on digital platforms.

2.2 Artist Residency Grants

The Artist Residency Grant helps emerging and professional artists from the UAE and beyond to create new work while connecting with Ras Al Khaimah's community through workshops, exhibitions, and collaborative projects.

Grant Eligibility:

Any Individual artists regardless of any nationality interested in creating new works and engaging in cultural exchange with the Ras Al Khaimah community. Must meet certain criteria. Applicants should hold a degree in studio or fine arts or have an established portfolio in media such as drawing, jewelry, mixed media, painting, photography, sculpture, or textiles. They should have completed at least one solo exhibition or two group exhibitions within the last three years and have proven experience in teaching hands-on workshops and activities. Artists must be at least 21 years old not enrolled in an academic program or residency during the proposed time with the Foundation, and must demonstrated proficiency in both spoken and written English.

Application Process:

Opens in early April 2025, with a closing deadline of 1 June 2025, unless specified otherwise. A complete application consists of an online form, a cover letter, a detailed artistic CV, an artist bio with a photo, a professional statement, a representative portfolio sample, a residency statement (including proposed community workshops), a list of supplies needed for the residency and two recommendation letters.

Grant Inclusions:

The residency provides support of up to 61,000 AED **to** cover eligible expenses. These may include economy round-trip airfare (if applicable), accommodation, a monthly living stipend, transportation costs, visa fees (if required), supplies and materials, and studio space. Funding allocations will be based on the artist's proposed budget, project needs, and duration of stay, without differentiation between UAE-based and international applicants.

Deliverables& Expectations:

Resident artists are required to hold six community workshops or lectures during their residency, organize a final exhibition at Ras Al Khaimah Art Festival, and submit a final report that summarizes their artistic work, community engagement efforts, and reflections on the residency experience.

Program Impact:

The Foundation aims to develop lasting creative skills in Ras Al Khaimah through its Film and Artist Residency Grants. It seeks to connect local and international artists and foster artistic innovation that enriches the Emirate's cultural scene.

By supporting creative talents, the Foundation strengthens the role of arts and culture as drivers of dialogue, education, and community cohesion in the UAE and beyond.

3 | Local Grants

The Local Grants program reinforces the Foundation's commitment to empowering communities through inclusive and participatory development.

By supporting grassroots initiatives, it enables residents and organizations to transform local knowledge and resources into sustainable solutions that enhance quality of life in Ras Al Khaimah.

3.1 Community Grants

The Community Grant program empowers Ras Al Khaimah residents and organizations to design and implement locally driven initiatives that address community needs through participatory and asset-based approaches. Projects must be realistic, measurable, and designed to strengthen social cohesion, inclusion, or wellbeing within local communities.

Grant Eligibility:

Ras Al Khaimah residents of any nationality or local organizations seeking to address a need or identified issue in the Ras Al Khaimah community. Proposals must demonstrate strong elements of community engagement, and project leaders must have lived in the emirate for a minimum of two years. For organization-based proposals, project leaders must also have been employed for a minimum of one year with the applicant organization and have documented support from their line managers. Where required, project teams should be comprised of diverse individuals and stakeholders.

Additionally, Collaboration and Partnership proposals require a minimum of two organizations or community groups working together, with documented evidence of in-kind support (for Collaborations) or matching funds/financial support (for Collaborations) beyond the grant request. Project teams must also have demonstrated proficiency in the Asset Based Community Development (ABCD) approach and concepts.

Regardless of the type of proposal, applicants should not have received a Community Grant within the last two years.¹

Application Process:

Community Impact Grant applications are accepted and reviewed on a rolling basis. Complete application includes: online form, cover letter, CV for project leader(s), list of project team members (as applicable), project proposal with timeline and deliverables, itemized budget that includes contributions of all key partners (in-kind or financial), letter of recommendation, letter(s) of support from participating organizations (as applicable), ABCD training certificate or similar evidence (as applicable), confirmation of research ethics training (research-based projects or those working with vulnerable groups).

¹ At its discretion, management may make an exception to this eligibility requirement if the proposal builds on the success of the earlier project and/or is deemed especially relevant to a community need.

Grant Inclusions:

Inclusions vary based on application category: Individuals (maximum 5,000 AED)², Organizations (maximum 10,000 AED), Collaborations (maximum 25,000 AED), Partnerships (maximum 50,000 AED).³ Funds may be used to cover direct, project-related expenses based on the approved detailed budget for programming, infrastructure, or capacity development initiatives.

Deliverables & Expectations:

Recipients must submit a brief midterm progress report and a final report upon completion, including photos, financial records, and impact assessment. Projects are expected to demonstrate sustainability by identifying local partners or resources that can continue the initiative beyond the grant period.

² As a special category of Individual awards, management may approve partial funding (up to 50% tuition fees) for teachers working in Ras Al Khaimah government schools to complete their M.Ed. at the American University of Ras Al Khaimah.

³ Funding for larger, well-justified projects may be considered on a case-by-case basis. However, such requests need to be submitted and planned well in advance to align with the Foundation's annual budgeting process.

2 | Application Review & Award Decisions

This section details the process and criteria used for determining awards for the Foundation's various funding opportunities. The Grant Manager is responsible for coordinating application reviews and communicating award decisions unless otherwise noted.

2.1 Research Grants

Doctoral Research, TransformRAK: Research for Tangible Impact Grants including Seed and Acceleration Research Grants are all considered competitive international awards and are collectively reviewed using the same process and criteria. The annual deadline for all three grant programs is 1 March (23:59 GST) unless otherwise advertised or the call is extended. Late applications or those received at other times of the year are generally not considered.

Review and Awards Process

The Foundation follows a structured, multi-stage process to ensure transparency, fairness, and consistency in all funding decisions.

Scoring and Evaluation Criteria

All complete proposals are evaluated using five weighted criteria forming the basis of award decisions. Sub-scores are combined into an overall evaluation score totaling 100 percent.

⁴ Conditional offers may be made for a number of reasons, including (but not limited to): outstanding IRB requirement; outstanding English proficiency exam; unconfirmed collaborators; budget or proposal adjustments. Exceptions, changes, or other actions required of the applicant are outlined in the conditional offer and built into the Award Contract as appropriate.

Reviewer Feedback and Finalization

Each reviewer provides both numerical scores and written feedback to support their evaluation. The Grant Manager consolidates reviewer comments into a summary report that informs the Foundation's final funding decisions and ensures a transparent, well-documented review process.

The Foundation research grant submission cycle (including Doctoral Research Grants) will reopen in November, with applicants expected to submit all materials through the online grants portal (Fluxx Portal – https://alqasimi.fluxx.io/) Review generally takes 6–8 weeks, and applicants are informed of their status by the end of June.

Applicants are strongly advised to plan ahead for Institutional Review Board (IRB) approval, research permissions, visa processing, and accommodation/transport arrangements before scheduling fieldwork in Ras Al Khaimah or the wider UAE.

2.2 Arts Grants

Film and Artist Residency Grants are competitive and collectively reviewed after the annual deadline. Late applications or those received at other times of the year are generally not considered.

Review and Awards Process

The Foundation follows a transparent, multi-stage process to ensure fairness and consistency in all Arts Grant funding decisions.

3	Applicant Interview	Shortlisted applicants are invited for an interview to discuss their proposal, clarify project details, and assess readiness for the residency. Interview outcomes contribute to the final decision-making process.	20%
4	Final Decision & Notification	Scores and internal feedback are consolidated into a final evaluation report. Based on composite results and available funds, final awards are approved and applicants are notified within approximately eight (8) weeks of the submission deadline.	10%

Note: The above weights reflect the relative importance of each stage in the overall evaluation process. The Foundation emphasizes external artistic review and community relevance to ensure that awards support creativity, innovation, and cultural engagement in Ras Al Khaimah.

- The Foundation may show flexibility for multiple Doctoral Research Grant recipients from the same institution when individual projects are of high quality and address distinct research topics.

Scoring and Evaluation Criteria - Film Grants

All complete Film Grant proposals are evaluated using five weighted criteria that form the basis for award decisions. Sub-scores are combined into an overall evaluation score totaling 100 percent.

Reviewer Feedback and Finalization

To accompany their overall evaluation scores, reviewers also provide their feedback on whether individual proposals should be considered for award funding. The Arts & Culture Department along with the Grant Manager prepare an overall review summary on each proposal to facilitate the final award decisions.

For Film Grants and Artist Residency Grants, the Foundation opens the annual arts and culture submission cycle in early April and closes it on 1 June. Shortlisted applicants are invited to interview, and final funding decisions are communicated approximately 6–8 weeks after the deadline.

Applicants should allow sufficient time for production planning (film shoots, equipment, locations, subtitling/translation) or residency logistics (housing, studio use, and community engagement commitments).

2.3 Community Grants

Community Grants are competitive and collectively reviewed using the same process and criteria, regardless of funding tier: Individuals, Organizations, Collaborations, and Partnerships. One primary application deadline is planned annually covering all levels of funding requests. A second submission cycle may be added pending fund availability.

Review and Awards Process

The Foundation follows a structured, multi-stage process to ensure transparency, fairness, and consistency in all funding decisions.

Community Grant applications are accepted and reviewed throughout the calendar year on a rolling basis. Eligible proposals are forwarded to the Selection Committee, and applicants can generally expect an award decision within approximately four (4) weeks. Funding is subject to budget availability.

Applicants should build in time for any required internal approvals (for example, partner signoff, matching funds, or ethics/training requirements for projects involving vulnerable populations) before beginning implementation.

3 | Award Details & Exclusions

Inclusions, deliverables, and exceptions associated with successful grant applications will be documented in a formal Award Contract signed by the award recipient(s) and Foundation. This includes identifying the party responsible for administration of award funds and ownership details for any equipment purchased as part of an award. Original Award Contracts are added to the award files and copies are provided to recipients for their records.

Evaluation of Requested Budgets

Foundation grant awards are modest compared to funding offered through other local and international entities. As such, budgets are critically evaluated during the application review process. When possible, applicants should submit supporting documentation (e.g. quotations) and show calculation assumptions to demonstrate how the value of specific line items is reached. Reviewers are also instructed to flag budget items that seem excessive or unnecessary, and such questions must be addressed before a conditional award offer becomes unconditional.

General Exclusions

To maximize the strategic impact of the Foundation's funding, the following items are excluded from award coverage:

- University overhead expenses or other indirect cost recoveries
- Salaries or stipends for faculty, researcher, or project leader time
- University tuition or fees (e.g. Doctoral Grants)
- Business class air tickets
- Conference attendance to present research results
- Journal processing fees

Case-by-Case Exclusions

In addition, reviewers often question inclusion of the items below. It is therefore important for applicants to demonstrate why such items are required for a project's successful implementation and note when they do not have access to such items through their university or organization:

- Technology or software purchases
- Journal subscriptions for literature reviews
- · Equipment rentals and purchases
- Research or project participant gifts
- External consultants or experts

4 Application Process and Timeline

The Foundation's competitive grants operate on an annual cycle for Research and Arts & Culture awards, and on a rolling basis for Community Impact awards. The process from submission to notification is structured to ensure clarity and equal opportunity for all applicants.

7.1 Application Steps

1. Review Grant Information:

Prospective applicants should thoroughly read this Application Guide and confirm that their proposed project aligns with the Foundation's objectives and eligibility criteria. Detailed descriptions of each grant type are available on the Foundation's website: www.algasimifoundation.com/grants.

2. Prepare Application Materials:

Applicants must complete all required documents listed in Section 1 of this guide. Templates for detailed budgets and other supporting documents are provided in the Appendices.

3. Submit Application Online:

Applications are submitted through the Foundation's secure portal (Fluxx Portal – https://alqasimi.fluxx.io/). All documents must be uploaded in PDF format. Hand-delivered or emailed submissions will not be accepted.

4. Acknowledge Receipt:

Applicants will receive an email confirmation within five (5) business days of submission from the portal and **grants@alqasimifoundation.rak.ae**. If confirmation is not received, applicants should follow up to ensure that their application has been properly recorded.

5. Review and Evaluation:

Following submission, applications undergo eligibility screening, peer review, and internal evaluation as outlined in Section 5.

6. Award Notification:

Successful applicants will be informed of decisions by late June. Those receiving conditional offers must address any pending requirements (such as IRB approval or revised budgets) before funds can be released.

Appendix H| Research Ethics CITI Training Instructions

A | Glossary of Terms

Applicant – an individual or organization who is considering or in the process of applying

for one of the Foundation's competitive grant opportunities.

Award – a general term that refers to any grant funding the Foundation offers to a

recipient.

Award Addendum – a formal letter that specifies changes to the conditions set forth in a

recipient's original Award Contract. This is usually issued after a successful

petition.

Award Contract – the formal agreement between recipients and the Foundation outlining

grant details, such as expectations of recipients, award inclusions, required deliverables and deadlines, award administration, ownership of purchased

equipment, and approved exceptions.

Award Period – the timeframe for which a grant is active. It includes an official start and end

date. All required activities and deliverables should be completed within this

time period.

Cancellation – an award that is declined when offered or ends before all grant activities

and deliverables have been met. Depending on the circumstances and how a cancellation is initiated, it may require partial or full-repayment for any

grant funds that have been spent.

Closure Letter – a formal letter that officially closes an open grant file. Under normal

circumstances, it will indicate successful completion of all grant activities and submission of deliverables. Closure letters will also be issued for cancelled awards, noting any specific conditions associated with the

cancellation.

Deliverable – a general term for any required event, publication, report, or other activity

demonstrating progress or successful completion of terms and conditions

set forth in the Award Contract.

Director — an individual eligible to apply for and receive a Film Grant.

End Date – the day a grant ends. All required deliverables associated with the award or

should be completed by this date.

Exception – a decision that reflects an exemption to an existing Foundation policy or

eligibility requirement.

Exclusion – an item that is not eligible for coverage in a grant or scholarship award.

Grant – funding provided through a competitive application process to an individual

or organization in order to carry out research, or an artistic or community

project based on a submitted proposal.

Grant Manager – the Foundation staff member responsible for grant promotion and

administration, as well as the main contact for applicants and recipients. The Grant Manager, with approval of the management team, may enlist other

staff to support certain aspects of these activities.

Inclusion - an item that is eligible for coverage in a grant award and outlined in the

formal Award Contract.

Local Recipients – any grant or scholarship recipient who is already based in the United Arab

Emirates.

Managing Editor – individual responsible for working with grant recipients on written

deliverables (e.g. policy papers, working papers, blogs) specified in the

Award Contract

Petition – a request to waive a Foundation policy or make changes to terms and

conditions outlined in a recipient's Award Contract.

Recipient – any UAE-based or international individual or organization that receives grant

funding from the Foundation.

Start Date – the day a grant begins.

Successful Applicant – an individual or organization who has been offered an unconditional or

conditional grant award but whose Award Contract has not yet been

finalized.

Visiting Scholars – individuals or organizations based outside the United Arab Emirates who

have accepted a competitive grant to carry out research or artistic projects

in Ras Al Khaimah.
